## PRECAUTIONARY STATEMENTS

## **Hazards To Humans And Domestic Animals**

Fatal if swallowed, inhaled, or absorbed through the skin. Causes substantial but temporary eye injury. Do not get in eyes, on skin or on clothing. Do not breathe smoke or fumes.
